1. Identify four barriers to teaching, and briefly describe why they are barriers.

Ans: Students may describe any of the following barriers to teaching:

Lack of time: Nurses may focus on other priorities or rush through the education process.

Lack of teaching competence: Nurses may be less likely to teach if they feel they are ineffective at it.

Lack of motivation to teach: If nurses don't view it as a priority, it may be short-changed.

Lack of administrative support and resources: Limited resources can negatively affect learning.

Lack of space for teaching and/or a lack of privacy: Distractions can interfere with both teaching and learning.

Lack of reimbursement for teaching efforts: May have the effect of reducing the time nurses spend on teaching.

Concerns about the effectiveness of patient education and violating clients' autonomy: Nurses may feel frustrated if their teaching efforts don't result in behavior change and then may reduce teaching efforts.

Insufficient documentation systems: Inadequate forms may result in insufficient teaching.

In the education process, assessment is focused on ascertaining learning needs, readiness to learn, and learning styles. In the nursing process, it is focused on assessing physical and psychosocial needs. The planning step for both processes

focuses on goal setting. The implementation step of the education process is when teaching takes places; in the nursing process, it is when nursing interventions are performed. The evaluation step in the education process involves determining what behavior changes occurred; this step in the nursing process focuses on assessing physical and psychosocial outcomes.

Low literacy and functional health literacy: Prevents clients from using instructions provided to them.

Hospital environment: Can cause feelings of loss of control and be demotivating.

Personal characteristics of the learner: Can relate to motivation to developmental capabilities.

Extent of change needed: Can be overwhelming and demotivating.

Lack of support: May block potential for learning.

Psychological obstacles: Lack of responsibility and denial can affect learning.

Structure of the healthcare system: Can result in frustration and abandonment of efforts by the learner.
