2. Describe the components of the DNP Scholarly Project as designated by the American Association of Colleges of Nursing (AACN).

Ans: As per the AACN whitepaper, *The Doctor of Nurse Practice: Current Issues and Clarifying Recommendations* (2015), the DNP Scholarly Project must meet the following criteria: (a) focus on a change that impacts healthcare outcomes either through direct or indirect care; (b) have a systems (micro-, meso-, or macro-level) or population/aggregate focus; (c) demonstrate implementation in the appropriate arena or area of practice; (d) include a plan for sustainability (e.g., financial, systems, or political realities, not only theoretical abstractions); (e) include an evaluation of processes and/or outcomes (formative or summative); (f) be designed so that processes and/or outcomes will be evaluated to guide practice and policy; and (g) provide a foundation for future practice scholarship.

Ans: Nursing philosophies, theories, and models serve as the foundation for delivery of patient care by the NP. Concepts described in nursing philosophies, theories, and models form the basis for excellence in nursing practice. Many approaches focus on the need for the healthcare provider to be open to patients' needs, to hear what they have to say, to understand what they really believe is wrong or right, and to let them work with the NP to develop goals. The ability of the NP to be culturally sensitive, and to be flexible and willing to collaborate and compromise when needed and appropriate, will help to form the framework for a successful patient–NP relationship, and most important, will assist patients in reaching a state of optimum health.
