Suggested Answers for Stop and Think! Scenarios, Chapter 1, The Health Care System

Suggested Answers for Stop and Think! Scenario

The students could include the following:

- Health care delivery has moved from the home environment to central locations such as offices, clinics, hospitals, and care facilities; individuals providing care are professionals who are required to complete specific higher education requirements and must seek certification or licensure before interacting with the public as a health care professional.
- The physicians knew their patients better and had more time to spend with them; the family remained as caregivers; decreased costs; many used the barter system as payment.
- Many individuals providing care were not trained; lack of proper sanitation techniques resulted in more infections and spread of disease (Black plague, cholera, influenza, etc.) especially in the "hospitals" of those days. Individuals without family members to help with their care had to depend on friends, were often forgotten and neglected, and died due to lack of care.
- Facilities can be centrally located to allow for more individuals to receive care and treatment; increased technology and equipment are expensive, a central location enables its availability to more individuals to occur; improved education has resulted in better care and improved results of care; certification or licensure requirements before delivering care as a health care professional help ensure the competency of the individual; improved sanitation and hygiene have prevented infections; surgery, pharmaceuticals, and technology have improved the outcomes and increased the life span and quality of life. Numerous laws are now in place to protect individuals and establish requirements for operation of facilities.

Suggested Answers for Stop and Think! Scenario

- Increased costs have made many choices unavailable to those in poverty;; lack of and increased cost of insurance and health care; some rural areas lack the facilities that provide more advanced care, individuals have to travel long distances for care, which can result in separation from family and support structure if an individual requires specialized treatment (i.e., a burn unit, a pediatric cancer hospital, a NICU, etc.).
