1. A group of nursing assistant students are contrasting the various names of medical professionals over the years. The group discovered that a "family doctor" of their grandparent's generation will most likely now be referred to as which name?
 - A. An in-house health care provider
 - B. A general practitioner

Answer: B

Rationale: The term "family doctor" has been largely replaced by "general practitioner" or "family physician." The other terms are not used to describe a physician.

Answer: A

Rationale: A holistic, humanistic approach focuses on the care of the whole person, physical and emotional. The best aspects of the care provided by the old-fashioned "family doctor" (i.e., the doctor's familiarity with the person as an individual) are combined with modern-day availability of specialized care when needed. Holistic care could be comprehensive, but that term is not used to describe this concept. Focused care usually occurs in the acute care setting or hospital where the staff is prioritizing treatment to help the individual recover from a specific disease or condition. General is not a common term used to describe an approach of health care.

Answer: D, E

Rationale: An assisted-living facility is a type of long-term care facility in which individuals can provide most of their own care, but may need help with medications, transportation, meals, or housekeeping. A long-term care facility is a nursing home which provides care for individuals who can no longer care for themselves. Both an assisted-living facility and a long-term care facility would be employment options for a nursing assistant. A nursing assistant would likely not

find work at the other establishments. A drop-in center provides recreational, educational, or counseling services to a particular group. A homeless shelter provides temporary housing for individuals without places to live. A community center is usually a building or group of buildings which provide a location for a community's educational and recreational activities.

Answer: A

Rationale: Hospice care focuses on relieving pain and providing emotional and spiritual support for the dying person and their family; therefore, hospice is the organization that would best suit this situation. An assisted-living facility provides care for individuals who can manage most of their daily activities but may require assistance with medications, transportation, housekeeping, or meals. A nursing home provides long-term care for people who are unable to care for themselves at home. A subacute care unit may still require certain treatment, but the focus is on rehabilitation before relocating the individual home or to a long-term care facility.

Answer: A, E

Rationale: The board sets policies to ensure that the care offered by the organization is safe and of good quality. The board also makes sure that the organization meets the needs of the community. The board then develops a plan to get funding to make necessary improvements to the organization, and to find qualified people to staff it. Research is usually conducted by universities, hospitals, or other organizations that specialize in that activity. Emergency services are provided by organizations that specialize in emergency and/or trauma care, such as fire departments, paramedics, government agencies such as the Federal Emergency Management Agency (FEMA), and nonprofit organizations, such as the Red Cross. State legislators are responsible for passing laws that address health care at a state level.

Answer: A

Rationale: DON stands for a Director of Nursing, the head of nursing services of an organization. Division of Nursing could be the name of the department of nursing, and a Directory of Nursing could be a list of all the nurses who are employed with a certain organization, but these would not be designations for a person. There is no specific title of "Doctor of Nursing", but there is the title of "Doctor of Nursing Practice" (DNP) which the nursing assistant may see.

7. A nursing assistant student is preparing a poster illustrating the Omnibus Budget Reconciliation Act (OBRA) of 1987. Which goal of OBRA should the student prioritize in the presentation when explaining the passage of this act?

 - B. Provide convenient transport services for clients or residents.
 - C. Ensure that the hospital's budget did not exceed a decided amount.

Answer: A

Rationale: OBRA was necessary because the quality of care provided in many long-term care facilities was inadequate; improving conditions was a major goal of OBRA. Local community or health care facilities, such as an assisted-living center or skilled nursing facility, may provide transport services. The board of directors is responsible for monitoring a hospital's budget. Reconciling differences between clients or residents and management would be handled by a legal department.

Answer: B

Rationale: The Occupational Safety and Health Administration (OSHA) outlines safety and health standards for those in the workplace in order to prevent injury; this includes setting standards to protect the employees from unsafe equipment, requiring certain standards and proper usage. The Omnibus Budget Reconciliation Act sets the standards for educational and skill requirements for health care professionals in order to protect clients and residents. The Center for Disease Control and Prevention (CDC) is responsible for setting the standards required to protect everyone from contagious diseases.

Answer: A

Rationale: The client or resident is always the primary focus of the health care team's efforts. The goal is holistic care provided competently by all members of the team. The other choices are secondary goals, which will help ensure the primary goal is met.

Answer: B

Rationale: In many instances, care that is provided for people must be documented in a detailed, specified way for reimbursement to be made. The other choices are beyond the scope of practice for a nursing assistant.

Answer: D, E

Rationale: The MDS report for each resident in a long-term care facility is required for Medicare reimbursements. Information, such as the person's weight, bowel and bladder habits, and level of assistance, is recorded regularly as part of the MDS report. Obtaining the individual's past medical history and food restrictions are beyond the scope of practice of the nursing assistant and would be completed by the RN or LPN. The cost of prescribed medication would not be collected.

Answer: B

Rationale: A humanistic approach to care focuses on the uniqueness and individuality of the person who is receiving care. This includes the individual's emotional, social, spiritual, and physical needs. It does not rely on the client being independent. Cooperation is also important but is not the main focus.

Answer: D

Rationale: People who live in assisted-living facilities often need assistance with some daily tasks (such as housekeeping, transportation, medication, and meals) but are independent enough to care for themselves most of the time. Subacute care

units are designed for individuals who are in the later stages of an acute illness. Recipients of Medicare and Medicaid may be at any of the facilities depending on their current health status. Individuals with social needs but no significant medical problems are not a focus of assisted-living facilities.

Answer: C

Rationale: Long-term care facilities are designed for people who are unable to provide their own care independently but whose medical condition does not require admission to an acute care facility. Hospitals provide care to individuals who have an acute medical issue. An assisted-living facility is available for individuals who are able to care for most of their basic needs but may require some assistance for activities such as transportation, housekeeping, medications, and meals. A hospice provides services for individuals who have a terminal illness and are given 3 to 6 months to live; this care may be provided in the home, hospital, assisted-living facility or a long-term care facility.

OSHA is responsible for setting the standards to ensure safety of all employees. OBRA is a law ensuring quality of life for individuals in a long-term care facility. A board of trustees is responsible for how that organization runs and is maintained.

Rationale: Successful inspection by the Joint Commission can result in a health care facility being accredited. Accreditation is an acknowledgement that the facility meets recognized standards of care. The other choices are some of the responsibilities of the board of directors of the organization which runs the facility.

Rationale: When discussing a resident's care or personal circumstances, it is necessary to take measures to protect confidentiality. The other choices are secondary reasons.

Answer: D

Rationale: The primary purpose of Medicaid is to allow individuals with low incomes to pay for medical care. Advanced age and disability may also qualify a person for Medicaid, but the most important factor is income level. Work history is not a deciding factor.

Answer: A

Rationale: The MDS focuses on the degree of assistance or skilled care that an individual requires. Therefore, the question the nursing assistant should prioritize is whether the resident can get to the washroom without assistance. Specific questions about a resident's medical status, activities, and allergies are beyond the scope of the MDS.

Answer: C

Rationale: The DHHS is primarily responsible for protecting and maintaining the nation's health. Other agencies and organizations exist under this umbrella organization, such as the CDC and CMS. OSHA is under the Department of Labor.

Rationale: Hospice organizations provide care to dying individuals and their families, such as the individual in the late stages of lung cancer. The other individuals would be appropriate candidates for a long-term care facility.

Answer: B

Rationale: Humanistic care involves a focus on the individual's thoughts, feelings, and uniqueness. Practical questions about medical care and function are not major focuses of the humanistic approach.

Rationale: OBRA sets out minimum training requirements for nursing assistants in long-term care facilities. Medicaid, the CDC, and The Joint Commission do not set these requirements, but cover other areas such as finances and appropriate care.

Answer: C

Rationale: If you do not know the answer to a survey inspector's question, say that you do not know the answer. This communicates honesty. It is not necessary to obtain contact information and provide an answer at a later time. It is better to say you don't know than to guess and give the wrong answer. There is no need to refer the inspector to a supervisor, but it is okay to ask a supervisor later for the answer.

Answer: A

Rationale: In a PPO, health care providers contract with an insurance company to accept a standard payment as total payment for services rendered and form a network for clients to choose from. In return, the insured person usually receives that care at a reduced cost. If the person goes out-of-network, they will be required to pay the full amount charged by the health care provider. These providers may be outside the client's community. Income and enrollment in government programs are not relevant.
